Development and regeneration

Compulsory purchase and compensation

Development and regeneration

- Advising Treasury Holdings UK on obtaining planning permission and listed building consent for its mixed use redevelopment

Litigation

The Council's final appeal will be heard by the Supreme Court in 2017.
