Digital transformation is impacting many sectors but possibly none more so than financial services. FinTech helped to forge a breakthrough which many other industries are also now following (insuretech, regtech, proptech to name a few) and continues to break new ground with innovation in structures, products, market architecture and solutions. In this session, we will offer a range of views from across a broad spectrum of participants in this space, discussing the impact on various aspects of financial services of this tech revolution and the current direction of travel.
