In addition, he headed the legal team that successfully brought suit against the Department of Treasury on behalf of the owners of the Al-Shifa pharmaceutical plant in Sudan that was destroyed by the US Navy.

## **Prior Experience**

From 1990 – 2004, George was a partner at the law firm of an international law firm, where he headed that firm's Middle East and USDOL practices.

From 1985 to 1989, George served as the Solicitor of Labor. As the US Department of Labor's chief legal officer, he was responsible for enforcing more than 130 laws that regulate the nation's workplace, including those guaranteeing minimum wage through the Fair Labor Standards Act, ensuring occupational safety and health pursuant to the Occupational Safety and Health Act, and maintaining pension security under the Employee Retirement Income Security Act. George headed a staff of 850 lawyers and support staff in 13 national offices and 16 regional and sub-regional offices around the country.

George played key roles in the Reagan-Bush 1984, Bush-Quayle 1988, and Bush-Cheney 2000 campaigns. In addition, he served as a member of the board of directors of the Overseas Private Investment Corporation and as chairman of the Tripartite Advisory Panel on International Labor Standards, the legal arm of the President's Committee on the International Labor Organization. On behalf of the Bush Administration, George served as an official observer to the Palestinian elections held in February 2005, and also as President George W. Bush's representative to the funeral of Palestinian Authority President Yasser Arafat.
